The agreed remainder of fees as indicated above, must be paid whether the course is attended or not, and enrolment is for the full duration of the course. A R250.00 admin fee will be levied monthly for each month of non-payment. If the contract needs to be cancelled due to special circumstances of the student after the course has already commenced: all account,/s must at that stage be paid up to date, written notification must be given and delivered, and the fees paid to date are not refundable.
